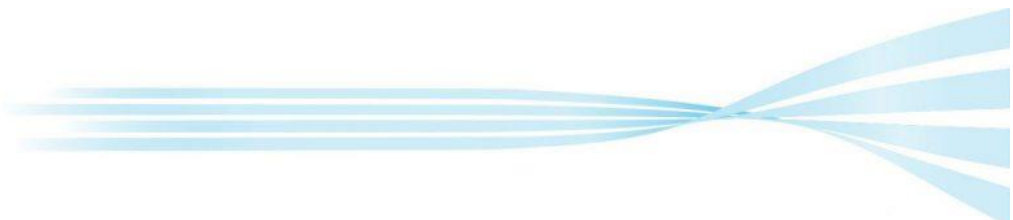

Key Tasks & Responsibilities

- Liaising with 3rd party suppliers and implementation partners to support the timely completion of All deliverables for any existing projects and provide local oversight of Corporate-level deliverables.
- Building close working relationships with business stakeholders, ensuring they are kept up to date and involved.
- Learning and maintaining knowledge of the reporting suite across Shared Services.
- Conducting detailed data analysis in collaboration with upstream product teams to define data requirements for shared service systems and ensure dependencies on other product teams can be resolved within required timeframes.
- Working with QA colleagues to support the robust testing of system changes.
- Conducting system prototype demonstrations to validate requirements with stakeholders.
