### Amendments to cover:

Section	Summary of Changes
<b>Loss of or damage to Your Vehicle sub-section</b>	An amended Section where You are: <ol style="list-style-type: none"><li>1. Required to pay the Windscreen Excess shown in the Schedule for each replacement; and</li><li>2. You are not subject to a limit on the cost of the replacement, but those costs should only be those costs reasonably incurred.</li></ol>
<b>Exceptions applicable to the Road Risks Section</b>	The following exception has been added: <ol style="list-style-type: none"><li>1. Any loss, liability or damage as a result of any Vehicle belonging to You or in Your custody or control being used for racing, pace making, used in any contest, reliability or speed trial irrespective of whether this takes place on any racetrack or circuit.</li></ol>
<b>Certificate of Motor Insurance – The Policy does not cover</b>	The Certificate of Motor Insurance is updated to make it clear that the Policy does not cover: <ol style="list-style-type: none"><li>1. Use for racing, pace making, use in any contest, reliability or speed trial whether formal or informal and irrespective of whether this takes place on any racetrack, circuit or otherwise.</li></ol>
